



EISA RE-ASSESSMENT AND LEARNER EXTENSION AGREEMENT

OCCUPATIONAL QUALIFICATIONS

This agreement forms part of the terms and conditions of enrolment with Shiloh Training and applies to all learners registered for Occupational Qualifications that require the successful completion of an External Integrated Summative Assessment (EISA).



1. PURPOSE

The purpose of this agreement is to ensure that learners understand the requirements and costs associated with additional preparation and re-assessment should they not achieve competency during their first EISA attempt.



2. LEARNER ACKNOWLEDGEMENT

By signing this agreement, I acknowledge and understand that:

- ✓ I have been informed that the External Integrated Summative Assessment (EISA) is the final assessment required for the completion of my qualification.
- ✓ I understand that passing all internal assessments and being registered for the EISA does not guarantee that I will be declared competent in the EISA.
- ✓ If I am found Not Yet Competent (NYC) or do not pass the EISA, I may require additional revision and preparation before attempting the assessment again.



3. EXTENSION OF LEARNER PORTAL ACCESS

I understand and agree that:

- ✓ My standard learner access period expires in accordance with my enrolment agreement.
- ✓ If I require additional time to revise and prepare for a future EISA attempt, I may request an extension of my learner portal access.

The extension fee is

R400.00

(Four Hundred Rand) per calendar month.

- ✓ The monthly extension fee grants continued access to the online learner portal, learning materials, revision resources, and academic support available through Shiloh Training during the extension period.
- ✓ Extension fees must be paid in advance before access to the learner portal is renewed.



4. EISA RE-ASSESSMENT FEES

I understand and agree that:

- ✓ Should I be required to rewrite the EISA, I will be responsible for paying the applicable EISA registration fee for each additional EISA attempt.
- ✓ The EISA registration fee is payable separately from the learner portal extension fee.
- ✓ Shiloh Training cannot register me for another EISA sitting until all applicable fees have been paid.



IMPORTANT INFORMATION

- Extension of learner portal access does not guarantee that I will pass the EISA.
- Payment of extension fees does not include the EISA registration fee.
- Payment of the EISA registration fee does not include additional months of learner portal access.
- It remains my responsibility to adequately prepare for the EISA.



5. LEARNER DECLARATION

I confirm that I have read and understood this agreement. I understand the costs associated with extending my learner portal access and registering for any additional EISA attempt. I agree to these terms and accept responsibility for the applicable fees should I require an extension or re-assessment.
